Option 2 – If you are unable to appear in person to submit this worksheet, you will need to provide a copy of your unexpired, signed, valid government issued ID (such as driver's license, military ID, passport, etc.) AND this Identity/Statement of Education Purpose Verification Worksheet NOTARIZED BY A PUBLIC NOTARY. The original notarized document must be received with the stamp/seal, and you must MAIL this form with the copy of the unexpired, signed, valid government issued ID to the address above. This document cannot be accepted via fax or email.

Option 1: Verification Statement - IN PERSON

The student must appear in person at UPENN SRFS (3451 Walnut Street, Room 100) to verify your identity by presenting a un-expired, signed, valid government-issued photo Identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport. UPENN SRFS will maintain a copy of your photo ID that is annotated with the date it was received and the name of the official at the institution authorized to collect your ID.
